01.25.01 CHAIR'S WELCOME

Chair Ian Southcott welcomed those present to the meeting.

01.25.04 PUBLIC PARTICIPATION – Bus gone through fence again (24/12/2024) just after it had been repaired from last time, causes noise disturbance both from diesel noise and reversing, no notification of extended bus timetable. Affected two listed properties without any notification. WPC to write letter to Essex Transport Group.

The ice on the road at corner of Hollow Road – salt offered from the stores and the yellow bins currently have some too.

Widdington Recycling – some of the soil piles are higher than usual and obstructing the view from properties in the village. Appears to be going across the field at a higher level. Polythene sheets and rubbish on WR side of the fence that are becoming unsightly. WPC to report to Essex planning officer. The ditch on Springhill is once again full of debris and full again with water after heavy rainfall. The culvert will be filled with debris again soon. WPC to write letter to Essex highways.

01.25.05 COUNTY COUNCILLOR'S REPORT – Local highways panel have approved signage for Springhill coming into the village (mixed use road sign), it is included in budget for next year and should be completed in first quarter (Cllr. Gooding will request the pedestrian sign is replaced). Footpath on high street will also be repaired. The drain on the corner cannot be done under the members package, a separate request has been made by Cllr. Gooding. Highways happy to go ahead with Hollow Road drain clearing, in talks with WR for lorry movement cessation, date still to be confirmed.

Devolution plans, ECC believe change to unitary authorities is inevitable and that being in the first wave will give more options for shaping how everything will go forward. County and District councils will cease in 2027. ECC broadly supportive.
