09.25.01 CHAIR'S WELCOME

Chair Ian Southcott welcomed those present to the meeting.

09.25.04 PUBLIC PARTICIPATION – Pothole at Cornell's lane just the middle of the pothole has been filled. Highways sign from February is still by side of the road. Bunting on pub from VE day is starting to fade, overgrown hedges are pushing road users into the middle of the road.

09.25.05 COUNTY COUNCILLOR'S REPORT - None

09.25.06 DISTRICT COUNCILLOR'S REPORT – Newport neighbourhood plan progressed, land allocated for development is the quarry and area near the station, for the 300 houses required under the local plan. Published in approximately a month's time, followed by 6 weeks public consultation. Have suggested that the quarry isn't infilled to original level and avoid visual of suburban sprawl towards Widdington and orientated towards Newport. Network rail planning to put traffic lights on railway bridge (near fire station) there to replace safe pedestrian crossing, engineers suggested moving entrance to chalk farm lane. Local plan expectation is that it will be approved by April 2026. District Cllr. Emanuel has a new role, member peer of the local government association and now cochair of the planning committee. Uttlesford planning is now out of designation.

Local government reorganisation first scenario has been published, UDC to vote on which scenario they support prior to their submission to the government, new authorities will start to exist by May 2026 and fully in place by May 2027.
